

Leicester Daily Mercury - 9 March 1896

It was originally known as the South Leicestershire League and was based at the Railway Hotel, Hinckley.



The Hinckley and District League was formally sanctioned by the English Football Association on Monday 9 September 1895.

Ten teams competed in the inaugural Hinckley & District League competition - Barwell Swifts, Broughton Astley, Burbage Albion, Croft Rising Star, Earl Shilton Excelsior, Earl Shilton Town, Hinckley Granville, Hinckley Great Meeting. Hinckley Town Reserves, and Stoney Stanton Rising Star.

The town of Hinckley was represented by three clubs and Earl Shilton by two.

All clubs apart from Hinckley Great Meeting completed the season.

Little information is currently known about the 1895-6 competition. Press coverage was poor, although League meetings were reported, from which odd snippets of information have been gleaned.

The Croft v Hinckley Granville game was ordered to be replayed, 15 minutes short time having been played. The gate was divided equally after expenses had been paid.

Hinckley Town were fined 1s being arriving late for their League game against Hinckley Granville.

Hinckley Town Reserves were ordered to pay Earl Shilton Excelsior 10s for non-fulfilment of a League fixture on 30 November.

Before Christmas the League changed its rules so that players who had taken part in the Senior Cup Competition were barred from playing in the Hinckley and District League.

Stanton players while journeying to Earl Shilton on Saturday 4 January 1896 their wagonette collided with another vehicle. The occupants of the Stanton brake which broke in two, were deposited in the mud. The horse bolted with one half of the brake. The players had to walk the remainder of the journey and after such an upset it was little wonder that they were beaten 6-0.

C Newcombe of Hinckley Granville was reported by the referee of the match against Hinckley United on 3 April for misconduct, and was suspended until 15 September.

The latest league table currently known is from 11 January 1896 – which is given above.

A match between the Champions (Barwell) and the Rest of the League was planned to take place on Easter Tuesday. The following players were chosen to represent the Rest of the League team: H Bradbury (Excelsior), J Chesterton and W E Forester (Earl Shilton Town), J Thorne and T Gregory (Hinckley Town), A Farndon (Stoney Stanton), W Hardy (Croft), C Robinson (Burbage), T Kenney and A Groves (Hinckley Granville). No report has currently been found for this match.

Barwell Swift players were presented with gold medals at the end of the Champions v Rest of the League, whilst the silver medals were given to the team representing the Rest of the League.

#### **Match Reports**

A selection of published match reports.

THE INTER-LEAGUE MATCH - This match, between the Leicester and District League and Hinckley and District League, was played at Shilton on Saturday last. Brown kicked off for Hinckley, who played down hill, and soon began to force the game, and for a few minutes the Leicester backs were called upon. Gibson relieved, and Buswell obtaining, raced up the field and passed to Edge, whose shot was easily saved by Underwood. More good work was done by the Leicester forwards, and from a centre by Curtis Buswell scored a fine goal. Re-starting, Palmer and Curtis put in some fine work, Underwood, the Hinckley custodian, saving some fine shots from, them. After this play ruled even, but in the last ten minutes, from a miskick by Wright, Heywood put in a good shot. Harrison saved, but Brown, being well up, equalised, the same player again putting through before half-time, when the score was: Hinckley. two goals; Leicester, one goal. Crossing over, Hinckley set to work, and soon began to press. For the first 15 minutes they did nothing but send in shots at Harrison, but he saved his charge splendidly, being cheered time after time. Relief came at last and Wood raced away, but could not get by the backs. Harding then passed over to Chapman, who ran well up, but without success. Hewett soon after scored the third goal with a fine screw kick. The Leicester men now showed evident signs of tiring, but Gibson and Baxter, defending well, managed, to keep the Hinckley forwards at bay. Hinckley Granville) was ordered to be re-played, 15 minutes short time having been played, the game to take place at Hinckley, and the gate to be divided after expenses have been paid, the date to be nutually arranged. The match Hinckley Town Reserve v. Hinckley Granville was ordered to stand as a League match, Hinckley Town being fined 1s. for being late in arriving.—Earl Shilton Excelsior reported Hinckley Town Reserves for non-fulfilment of fixture on Nov. 30th, and Hinckley was ordered to pay Earl Shilton 10s., the amount claimed for expenses, the match to be played at Shilton on February Sth. — It was agreed that the Emergency Committee meet at an early date after the draw for the Junior Cup to select the team against the Leicester and District League, to be played at Earl Shilton on January 11th.

The minutes of the last meeting were read and confirmed. The match Burbage Albions v. Stanton, through 20 minutes short time being played, was ordered to be replayed at Burbage, date to be mutually arranged. Stanton to take half gate after expenses have been paid. The Burbage Albion was fined 1s. for not having been ready to play the match at the advertised time. - The case of the Hinckley Town v. Hinckley Granville was adjourned until the next meeting of the League, the secretary to lay the full facts of the case before the members of the Leicestershire Emergency Committee, and report to League.
