

NUNEATON TOWN F.C.

The hon. sec. reported that the Nuneaton Town F.C. had paid the fines due from them amounting to 22s., namely, 17s. to Shilton Excelsior and 5s. to Hinckley Granville. The hon. sec. further stated that if the club could see their way to raising a team for next season they would be pleased to join the League.

THE INTER-LEAGUE MATCH.

A communication was read from Mr. R. A. James, hon. sec. of the Leicester and District League, stating that he desired to thank the Hinckley and District League committee for their offer to play an inter-league match, but the committee thought that as the matter was not taken up earlier in the season, and several of their clubs being behind with their matches, the interleague match had better be postponed till another season.

SENIOR PLAYERS.

Some discussion took place respecting the proposed alteration of the rules relating to senior players, but in the end it was decided that the question be deferred until all the clubs in the League had had a full opportunity of considering the matter and making known their views upon it.

An application was received from the Burbage F.C. to join the League, but it was agreed to defer sanction until after the annual general meeting, which was fixed for the second Wednesday in June, as per rule.
