Burbage again won the championship of the Hinckley Leage without "tasting defeat" and reached the semi-final stage of booth the Leicestershire Junior Cup and Nuneaton Minor Cups. "The Granville also had a successful season, but Shilton Victors have been disappointing. At the outset they looked like taking all before them, but they have finished in poor style – Hinckley Free Press – 5 May 1899.

It is no known why Stoney Stanton finished as runner-up.

A new ruling of the Leicestershire FA introduced during the season required the signing of all club members on new association forms before they could be recognised as bonafide members.

At the meeting of the Executive Committee of the Hinckley and District held at the Wentworth Hotel, Elmesthorpe on Saturday 17 December 1898:

- Stoney Stanton FC were reported by Stockingford for rough play and interference by spectators in their match at Stanton. The complaint of rough play was not upheld by the committee but they agreed that the Stanton Club be asked to have bills printed and posted in the field cautioning spectators;
- Mr W Spence, referee, reported Croft FC for being late in their match with Earl Shilton at Shilton on 3 December. Croft were cautioned;
- Mr T King, referee, reported Barlestone FC for being half an hour late on arrival at Burbage on 26
   November, and Burbage FC complained of a loss on the gate owing to the late arrival of the visiting team
- Barlestone were fined 5s and cautioned. The match was ordered to be replayed, the gate money to be divided equally between the teams.
- Granville FC were fined 3s and cautioned for failing to keep their fixture with Barlestone;
- Stoney Stanton FC reported the non-attendance of the referee in their match with the Reserve team on 26 November in the minor League. The match was won by Croft, who asked that the result stand as a league match. As the match was agreed upon before the commencement to be a

- friendly it had t stand as such. The match was ordered t be replayed and the gate money equally shared. Mr Tomlinson, the referee in question, stated that he did not get the postcard until the day of the game. Hiss excuse was accepted.
- Stockingford FC having been fined for late arrival at Stanton by the executive at a previous meeting, wrote asking that the result stand as a win fr Stanton. The committee decided to stand by their former decision that the match be replayed

At the January 1899 meeting of the Hinckley and District League, Mr Hawkins (hon. secretary) stated that the League had a balance from last year of £7, which, with subscriptions etc., had been brought up to about £16. Payments had been about £5, and there were due to clubs for deposit money about £8 8s, s that there would be about £3 to the good at the end of the year.

Over 800 players were registered to the League



Waring of Burbage, when the following representatives were present Burbage: Messrs. H. Gent, and J. Waring; Hinckley Granville, Messrs. F. Kenney and T. Baker, ; Stoney Stanton, Messrs. A. Farndone and J. J. Jarvis; Shilton Victor, Mr. H. Bown; Narborough. Messrs. T. H. Ward, and J. H. Sharpe, ; Barwell, Messrs. W. Bray and A. C. Bywater; Earl Shilton Town, Messrs. J. Worthington and H. Orton; Croft, Messrs. W. Warren and A. Smith; and the hon. secretary, Mr. J. T. Hawkins, Hinckley. In reference to the new ruling of the Leicester F. A. re the signing of all members of every club on the new association forms before they could be recognised by that body as bona-fide members, it was agreed that all clubs in the League be granted till February 6 to get their members' signatures, but that the clubs use their influence to get members signed before that date. The resignation of the secretary, was next considered, and after regret had been generally expressed at his retirement from the post, Mr. Arthur Grewcock, of Barwell, was appointed. It was also agreed to start a fund for the purpose of presenting Mr. Hawkins with a testimonial at the end of the season, when his resignation takes effect. Mr. Hawkins subsequently stated that the Selection committee for the inter-league match with Leicester District had the matter well in hand, and the final selection would shortly be made and the match played at Hinckley on February 25. HINCKLEY AND DISTRICT FOOTBALL LEAGUE.—A general meeting was held at the Railway Hotel, on Monday evening, under the presidency of Mr. H. Horton (Earl Shilton). There were also present-Messrs. A. Farndon (Stanton Reserves), H. Bown and A. Jordan (Shilton Victor), J. Waring (Burbage United), C. A. Bywater (Barwell), T. Ward (Narborough), F. Kenny (Granville), E. Biddles (Hinckley Victor), and J. T. Hawkins, hon. sec.—A letter was read from Mr. A. Grewcock, of Barwell, resigning his position as secretary, and Mr. H. Bradbury was unanimously appointed, on the motion of the Chairman, seconded by Mr. Bywater. - The championship match was for Tuesday, April 4th, at Burbage, when that team will be opposed by a team selected from the clubs in the League as follows :-Lovell (Barlestone), goal; Harding (Granville), right back; Cutler (Narborough), left back; Ellis (Stanton), right half-back; Martin (Granville), centre; Barker (Barlestone), left half-back; Ball (Shilton Victor), outside right; Lovett (Stanton), inside right; Smith (Narborough), centre forward; Crick (Croft), outside left; Elverstone (Shilton Victor), inside left. Referee, Mr. J. T. Hawkins; linesmen, Messrs. T. Ward (Narborough), and H. Bown (Shilton Victor).—It was resolved to ask Mr. C. C. Hurst to kick off.—A discussion ensued with reference to the match on Saturday last between Stanton and Shilton Victor Reserves. In consequence of the referee being unofficial, Mr. Farndon protested against the match, and contended it should be replayed .- Mr. Bradbury moved: "That the protest be lodged in the usual way."-Mr. Biddles seconded.—Mr. Waring proposed as an amendment that the match be replayed, and Mr. Farndon seconded.—On being put, three voted for the proposition and five against. The match will be replayed, and also the matches between Granville and Burbage first and second teams, Shilton Victor first and second teams on the usual cup-tie terms. The date of the match between Shilton Victor Reserves and Shilton B team was altered from April 8th to April 22nd .-The medals were chosen, and subscription lists handed round for the proposed testimonial to the late secretary, Mr. J. T. Hawkins.

The Granville football club was reported for non-fulfilment of fixture on April 8th. and was fined 2/6 and ordered to pay referee's expenses, and was censured. This match was to be played on the Granville ground. This club was also reported for the same thing at Earl Shilton on April 4th., and had to pay 2s. for ground marking. Both these matches were ignored from the league chart. The league decided to present the secretary (Mr. J. Hawkins) with a gold albert with pendant, and a silver watch, on his retirement.

After the presentations, the chairman in the course of his remarks said the idea of having a second division was a splendid one. They were training those who would ultimately step into the first division. The want of it was felt with the Barwell club. They had no one to take the place, no one in training, and so there were no prospects. He congratulated Stoney Stanton upon the fight they had made, He was glad the goal average did not count. He did not believe in it. Supporting his views, he said clubs low in their funds would do almost anything. They could be squared for a pseuniary consideration. But they would notice in the local papers that the Hinckley bakers did not carry out this spirit, and had been throwing out nasty insinuations. He was sorry to see that the editor of the Free Press had sanctioned that spirit. It was not a nice spirit at all. It might cause sweating! well it would not make him sweat if it did'nt the Editor. As true sportsmen they should be able to lose as well as win.

#### PRESENTATION TO MR. HAWKINS.

The chairman said he had the pleasure of making a presentation to Mr. J. T. Hawkins who was resigning the secretaryship of that League. No words could adequately express the good Mr. Hawkins had done to the League. (Hear hear). He was chiefly instrumental in the League being formed, by his energy, determination and persistence. He had felt compelled to resign, and the executive felt they could not allow the occasion to pass without making him some kind of present. He had therefore great pleasure in asking Mr. Hawkins to accept a silver watch and chain as a token of their feelings and esteem. The present would have been much more valuable had their funds been better. However it was a sincere gift for his work in introducing the League into the district. (Applause).

Mr. Hawkins who was well received thanked them heartily for the present. He was sorry to have to give up the secretaryship but he had not the time necessary to spare. He would however render every assistance to Mr. Towers who had been appointed to succeed him. Hinckley Town were not considered good enough for the Leicester and District League so they formed their own league. After referring to the notable successes of the clubs in the league, he asked the secretaries of the various clubs to make the new secretary's work as light as possible by promptness in correspondence, &c. The League was not quite at its best at the present time, but there was a lot of work to be done. He hoped the League would prosper and continue for many years. (Applause). The usual votes of thanks closed the proceedings.
