After fifteen minutes Randon found the net, but the whistle had previously sounded for an infringement of the offside rule. Neddy Thompson, however, shortly afterwards shot through grandly, and the home supporters were on good terms with themselves, but the referee, Mr.

Blore, of Leicester, did not allow a goal, and ordered a goal kick. It was hard lines for the Hathern lads to have two apparently good goals disallowed considering how well they had played, but Bernard Warren at last secured a sound goal after some dashing play by the Victoria forwards. The Hathern eleven were showing capital form and seemed to be excellent condition. A misunderstanding between Thompson and Berrington let in Harris and Lindsey accidentally fouled, a free being awarded from which the scores were made equal. Half-time arrived soon after. The Leicester Leaguers were confident of victory, but the Excelsiors, although knowing but little success in their respective League, were determined on having a bit better luck with this match, and through kind permission of the Loughborough Victoria club, who loaned them Joe Mounteney and G Unwin, they were enabled to place a strong eleven in the field. Mr Allen Lovell, chairman of the Association, officiated, the elevens being as follows:

Excelsior: W James; W Lockwood and H Flanders; A Ward, J Smith and H Bradley; J Mounteney, G Unwin, A Disney, J Oram and H James.

The home side kicked off and were soon round the Excelsior goal, a corner being conceded, and after a scramble in front of goal the ball was rushed through in the first three minutes – which looked a bit “seedy” for the visitors.
