Little is currently known about this village football competition apart from the information given below

The League, open to Village Clubs within a 7 mile radius of Belvoir, was formed at meeting was held at the Peacock Hotel in Belvoir on 21 October 1896. The following clubs were represented – Woolsthorpe, Denton, Muston, Knipton and Stathern.

Stathern withdrew from the League in April.

It is not known whether the League was completed.

Match Reports

FOOTBALL.—The new Bottesford club played their first match-a Belvoir League one-on Saturday last. The venue was Mr. Sherwin's field on the Belvoir. road, and Bottesford's opponents were Stathern—or, perhaps more correctly, Harby and Stathern. The visitors were returned the victors, obtaining three goals in the first half of the game and two in the second. For Bottesford, the backs played a good game, particularly Captain Hollingsworth, but the rest of the team did not appear to be particularly dangerous. Considering that it was their first game together, however, the players may feel fairly satisfied. Furmidge (outside right) played a good game for Stathern.

STATHERN OLYMPICS V. KNIPTON WANDEBERS .- After five weeks' rest, the Olympics were engaged, on Saturday last, in a League match under the Belvoir and District Rules, their opponents coming from Knipton. A moderate number of spectators witnessed the contest, the home team being under the captainty of B. P. Bird. Winning the toss, the visitors, who played nine men, decided to face the town end goal. WOOLSTHORPE-BY-BELVOIR.

FOOTBALL.—The home team played Stathern Olympics at Woolsthorpe on Saturday. Considerable interest centred in the match, it being a Belvoir League fixture. Woolsthorpe had shown such poor form against Bottesford the week before, that their supporters felt very dubious as to the result of Saturday's encounter. The Blues, however, played up in their true form, and, after a capital game, ran out winners by three goals to none. This victory placed Woolsthorpe once more at the top of the League.

FOOTBALL.—A meeting of the Belvoir and District League was held at the Chequers Inn, Woolsthorpe, on the 4th inst. Amongst those present, besides Club representatives, were Dr. Macdonald, in the chair, and the Rev. E. E. Farmer (Bottesford). The principal business was the appointment of referees for March, and the arrangement of postponed fixtures. Bottesford agreed to play Woolsthorpe the return match on the 20th inst., and Stathern at home on April 10th, and away 24th prox. Woolsthorpe and Knipton arranged their postponed fixture for Good Friday. A scheme for obtaining medals for the champions was also discussed, and it is hoped that the winners in the competition will play the pick of the League a match for the benefit of the League.

FOOTBALL LEAGUE.—The adjourned meeting of the Belvoir District League was duly held at the Peacock Hotel on Tuesday evening. All the officers were present, viz., Dr. Macdonald, president; Rev. E. E. Farmer, vice-president; Messrs. W. R. Barber and F. Bonshor, treasurer and secretary respectively; and, in addition, the following clubs were represented, viz., Muston, Bottesford, Woolsthorpe, Knipton, Denton, and Stathern. The minutes of the first meeting were read over and confirmed, and other rules were made. It was decided that, as the season was already somewhat advanced, the half-dozen clubs mentioned above would be quite sufficient for a League this year, though it was hoped the number of clubs would be raised to nine or ten another season. Fixtures were then arranged, Saturday, Nov. 7th, being the date of the first match.

FOOTBALL .- Referring to the meeting of the Committee of the Belvoir Football League, held at Belvoir, on Tuesday evening last, to consider the protest raised by Weelsthorpe against the result of their match with Bottesford on Boxing-day, a correspondent writes:— Our readers may remember that the game ended in a victory for Bettesford by 2 goals to 0, but unfortunately the Referee, through some mistake, closed the game seven minutes to time. After some discussion, the voting for and against the re-playing of the match was equal, and Mr. Bonshor, the non. secretary of the Woolsthorpe Club, who presided in the absence of Dr. Macdonald, the president, was placed in the unenvisble position of having to give a casting vote. Of course, he did what his Club expected him to do, in spite of the fact that the Referee stated as his opinion that Woolsthorpe would never have scored had the additional time been played. The Committee of the Bottesford Club have decided, owing to such unfair treatment, to withdraw from the League, and in future play only "friendly" matches. The League system in village football is undoubtedly the cause of a lot of wrangling and squabbling, which cannot conduce to the welfare of the game.

FOOTBALL .- A meeting of the Belvoir and District League was held at the Chequers Iun, Woolsthorpe, on Tuesday evening, 19th inst. The following representa-tives were present, viz.:—Mesars. Barber and Heald (Woolsthorpe), Daybell and Hollingsworth (Betterford), Cunnington and Smart (Knipton), Geo. Pearce, New-man, and F. Scoffield (Denton), and F. Bonshor, hon. secretary of the League. In the absence of Dr. Macdonald (Fresident of the League), Mr. Geo. Pearce was manimously voted to the chair. The first business was the consideration of a protest by Stathern Olympics re their match with Bottesford, on 9th inst. Stathern alleged that, in consequence of the Bottesford socretary stating at the last League meeting that because the protest re Boxing-day match with Wools-thorpe was decided against them Bottesford F. C. would withdraw from the League, they only prepared for a friendly match on the 9th inst. Several of the men they played were not registered, and, under all the circumstances, they did not think the match ought to stand good as a League fixture. After some discussion, Bottesford intimated their willinguess to re-play the match, which satisfactorily disposed of the protest. Muston having sont a very insulting post-card to the Secretary of the League, immediately after the last League meeting, wherein they signified their withdrawal from the League, it was decided that their resignation be not accepted till they had given satisfactory reasons for not carrying out their fixtures. This resolution debars their players from joining any other Club in the League for the time being. Bottesford wished to re-open the question of their match with Woolsthorpe on Boxingday, which at the last League meeting was ordered to be re-played. By a substantial majority, the decision of the last meeting was upheld. Bottesford then arranged to re-play the match on a date in February. A proposition by Bottesford, that in future a protest shall be accompanied by the sum of los. instead of 2s. 6d. as hitherto, was carried by five votes to four. The appointment of referees for February concluded the business of the meeting. On the motion of Mr. D. R. Daybell, a hearty vote of thanks was accorded to Mr. G. Pearce for presiding.
